Public Participation Notes

The Chairman invited members of the public to speak and comments received included the following –

The Chairman of Marlingford & Colton Parish Council discussed issues as below with Easton Parish Councillors –

There is lots of development and it is useful to have a dialogue

Persimmons Phase 3 – nutrient neutrality – concerned about the outflow and there was a lengthy discussion

Easton Parish Council is commenting on applications but finds no other comments and encourages responses to be made

Brief reference to Latimers' project, Easton Parish Council had a positive meeting recently where infrastructure seemed to be the focus

Community Car Scheme – Only providing a limited service in Marlingford and Colton, however, Easton Parish Council is fully supportive of the scheme and feels it is necessary at this time, notes there is no bus service to the Doctors

Grapevine funding – Marlingford & Colton Parish Council give funding but were now producing their own parish council newsletter, what is Easton Parish Council's view? Easton Parish Council do not fund directly but do give grants and Covid Recovery grant money is still available. Mainly funded by advertising and feel the online version is working well, Easton is too large an area for hand delivery by Easton Parish Councillors

There are 2 speed cameras in Marlingford and Colton, they are particularly concerned about speeding along Marlingford Road and are generating data

NCC & SNC Cllr Dewsbury had supplied a written report for the Annual Parish meeting which was previously circulated and noted.

The following additional comments were received -

Queried the timings of Easton Parish Council meetings – Councillors confirmed there had been more attendees at the last meeting which was at the same time and Agendas had been posted well in advance. The timing of meetings were set to ensure Councillors could attend and be quorate.

South Norfolk and Broadland Councils have now agreed to share the same headquarters, financially it makes sense. There will be alternative places to meet if required, they often use libraries and assist people with IT etc.

Cllr Dewsbury is responsible for 14 different services.

Adult Education have received applications for English as a Foreign Language course from 200 Ukranian refugees

Visited the Food Hub to see how everything is progressing, looking at a development order for South Norfolk side

VAS signs were briefly discussed as Norfolk County Council has requested they are removed in Easton because of the post locations. Easton Parish Council is confused as in 2017 the locations were acceptable and installed by Wescotec in liaison with Norfolk County Council Highways. There is great concern if accidents occur as Easton Parish Council have been made to take down the signs – Cllr Dewsbury will investigate this matter

Easton Parish Council also reiterated previous requests for street lights to be turned off in line with dark skies policy in the Easton Neighbourhood Plan

Norfolk County Council needs to save £60 Million next year and with the cost of living increases they are trying to make budget savings
