There are concerns South Norfolk Council may be reluctant to pass on the £500,000 promised although this money is already spent. The project was going well and were ready to pour slab this week. There will now be unavoidable delay and will take legal advice. WTD is still operating and finalising for SIPs to build. A press statement will be made.

## **Public Participation Notes**

The Chairman invited members of the public to speak and comments received included the following –

NCC & SNC Cllr Dewsbury – Queried why the Councillors chose the specific contractors –

Councillors response - EPC went through an open book process to keep the costs down and the contractors removed profits margin as it was a project for the community. This contractor was doing work for big clients, Tesco and Barclays etc and a good contract was in place. Unfortunately, it is now a similar situation to Queen's Hill development.

NCC & SNC Cllr Dewsbury – queried if EPC will hold meetings more frequently to discuss the project

Councillors response - EPC will call extra meetings if required but there are so few Councillors running the Council, residents need to be prepared to "step up". The Council offered a grant of £500 for a Coronation event but received no applications from residents or groups, it was very disappointing.

Resident asked if the current schedule of 4 meetings per year was sufficient – Councillors response - Confirmed 4 meetings will be held during the municipal year with the option to call extra meetings if required. It was reiterated the Councillors are doing their best with so few of them, the recent elections were disappointing with no new Councillors coming forward
